## WHAT WE DO

### Scopes

When needed, our team works with the insurer to create a scope that accurately reflects the details of what the insured policyholder had before their large loss claim. Proper care, attention, and diligence is critical to providing bidders with a reliable document to price from.

### Estimates

We efficiently submit accurate estimates within two weeks of receiving a scope. Industry-standard estimating softwares can't compete with the precision of our local builders' expertise and up-to-date regional pricing knowledge.

### Demolition

Expedited and professional removal of a damaged structure is vital to ensure safety and reflect responsibility to the insured and the community surrounding the traumatic event. As time is of the essence, we can provide immediate demolition or, if required, supply an estimate within 24 hours of notification of the incident. We communicate with the building departments and officials that issue demolition permits and facilitate the early stages of the site management process. Additionally, Designated Substance Reports and Assessment Control Programs for any Environment Abatement issues are available if required.

### Engineering

It is critical to prevent liability concerns and ensure a highly professional and credible review procedure throughout the loss replacement process. Many demolition permits require having an engineer cover and direct the removal. Our third party expert engineers will be available to inspect the site to determine the structural damage – defining the site as a partial loss or total loss. We also work efficiently with any engineering firm appointed by the insurance company or adjuster who provides instruction and direction throughout the claim.

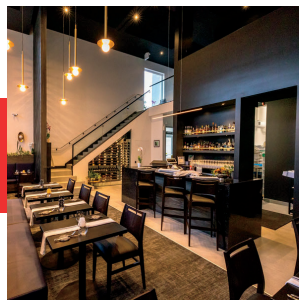

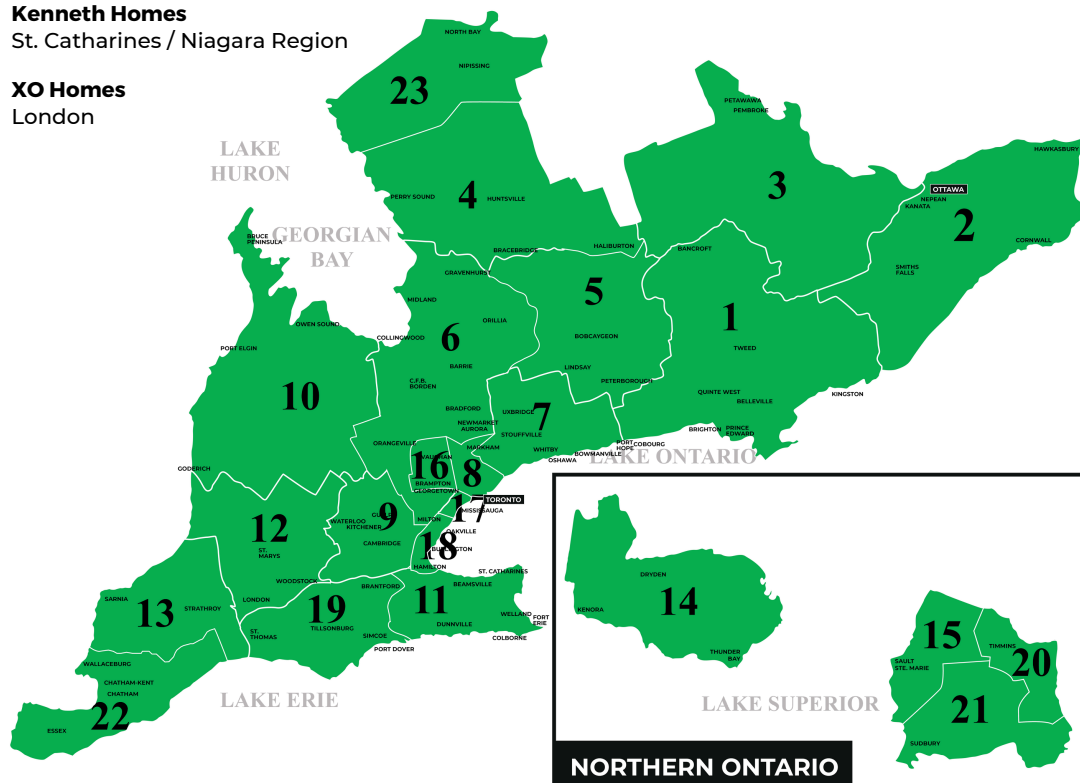

Rebuild Response® does not offer emergency clean-up or minor restoration services, but we specialize in the necessary turn-key construction services for large property losses.

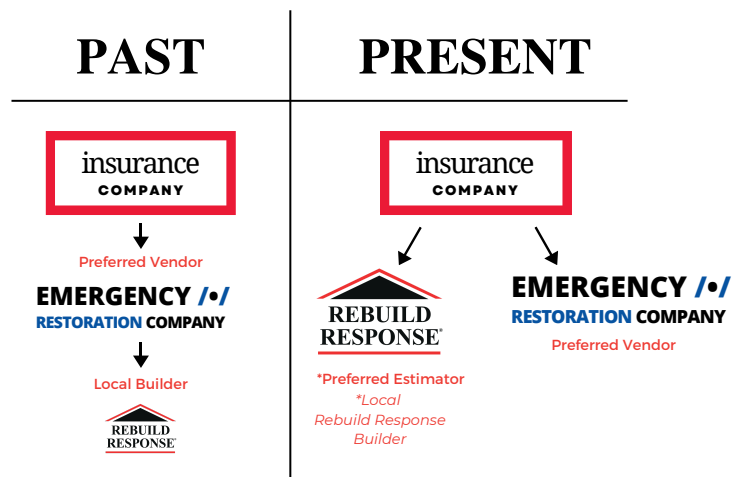
The Rebuild Response® team consists of the top Tarion-approved custom home builders to provide consistent estimating and rebuild services across Ontario. Our builders utilize professional expertise and current costs to submit thorough, detailed estimates within two weeks of receiving the scope. While restoration companies' industry-standard estimating software programs can be instrumental in pricing restoration work, they may be inaccurate when estimating a total rebuild because of insufficient regional cost tracking.

Most restoration companies do not have the resources or expertise to provide turn-key construction services, they generally sub-contract the rebuild portion of the claim to a local builder and add a 10-15% profit margin to the local builder's project price—inflating the overall build budget. This approach also adds a go-between to the already complicated communication and claim management process.

**Working directly with a Rebuild Response® builder for large property loss reconstruction instead of being sub-contracted through a restoration company prevents an inflated rebuild budget and poor efficiencies. It also limits the logistical elements of involving an extra party in the claim management process.**
